

## Consent Form

This form explains how and why FIRST UK a registered charity (1178433) may use images and videos of you or your child. Please read the form thoroughly and outline your agreement as appropriate.

### ***Why do we need your consent?***

During the events ran by FIRST UK, images and/or videos may be taken of the participants. FIRST UK will not use images and videos of the participants without your consent.

### ***Why do we use images and videos of your child?***
